

**RESOLUTION No. 17-143**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT WITH CERES ENVIRONMENTAL, ASHBRIIT ENVIRONMENTAL, AND DRC EMERGENCY SERVICES FOR THE PROVISION OF EMERGENCY DEBRIS REMOVAL SERVICES UNTIL DECEMBER 31, 2017 UNDER THE SAME TERMS AND CONDITIONS AS THE EXISTING AGREEMENT, WITH COSTS INCURRED ONLY UPON THE CITY'S REQUEST FOLLOWING AN ACTUAL EMERGENCY; AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT AND TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on August 20, 2013, the City of Doral (the "City") entered into a two (2) year contract with two (2) one-year (1) options to extend with Ceres Environmental (Ceres), AshBritt Environmental (AshBritt), and DRC Emergency Services (DRC) for the provision of emergency debris removal services as approved by Resolution No. 13-67; and

**WHEREAS**, on August 20, 2016, the City executed the final option-to-extend which will expire on August 20, 2017; and

**WHEREAS**, during the contract period, Ceres, AshBritt, and DRC have provided exceptional service to the City at no cost to the City; and

**WHEREAS**, this request will allow the City to properly respond to any emergency throughout the duration of the 2017 hurricane season, and will also allow the Public Works Department to re-advertise these services and create an agreement that will not expire during the middle of a subsequent hurricane season; and

**WHEREAS**, staff has recommended that the City Council authorize the City Manager to execute the extension letter, a copy of which is attached hereto as Exhibit "A",

for Ceres, AshBritt, and DRC, which will be under the same terms, conditions, and prices as the original contract.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The extension of existing agreements between the City of Doral and Ceres Environmental, AshBritt Environmental, and DRC Emergency Services for the provision of emergency debris removal services until December 31, 2017, under the same terms and conditions of the existing agreement, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the extension letters and expend budgeted funds on the behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
