A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA RANKING THE SUBMITTED PROPOSALS FOR THE PROVISION OF ENGINEERING SERVICES AND RELATED DISCIPLINES FOR NW 114TH AVENUE PARK; AUTHORIZING THE CITY TO NEGOTIATE **PROFESSIONAL** MANAGER Α SERVICES AGREEMENT WITH THE TOP RANKED FIRM, AND IF AN AGREEMENT CANNOT BE REACHED WITH THE TOP RANKED FIRM, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AN AGREEMENT WITH THE SECOND OR THIRD RANKED FIRM, RESPECTIVELY IF AGREEMENT CANNOT BE REACHED WITH THE SECOND RANKED FIRM; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFQ #2013-29 titled "Engineering Services and Related Disciplines for NW 114th Avenue Park" the City of Doral received six (6) responses by the December 18, 2013 at 11:00 a.m. deadline; and

WHEREAS, upon review of the submittals received it was determined that all the firms met the required criteria; and

WHEREAS, three (3) firms were shortlisted and oral presentations were held on February 14, 2014; and

WHEREAS, an Evaluation Committee has ranked and scored the all the proposals; and WHEREAS, the Evaluation Committee recommends to the City Council that it accept the rankings of the firms that submitted proposals and authorize the City Manager to negotiate a professional services agreement for Engineering Services and Related Disciplines for NW 114th Avenue Park with the top ranked firm, or if the negotiations fail with the top ranked firm, then negotiate a professional services agreement with the next highest ranked firms successively until an agreement is reached for the subsequent submittal to the City Council for review and

approval.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> <u>Approval of Rankings.</u> The City Council hereby ranks the top three (3) firms that submitted proposals in response to subject Request for Qualifications (RFQ #2013-29) as follows:

- 1. Wannemacher Jensen Architects
- 2. Gould Evans
- 3. Arquitectonica GEO

Section 3. Authorization. The City Manager is authorized to negotiate a professional services agreement for Engineering Services and Related Disciplines for NW 114th Avenue Park with the top ranked firm for subsequent submittal to the City Council for review and approval. If negotiations are unsuccessful with the top ranked firm, the City Manager is authorized to proceed with negotiating an agreement with the next ranked firm or firms in the order of ranking.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
