

**RESOLUTION NO. 15-04**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN INCREASE TO THE PURCHASE ORDER FOR LDV, INC. IN THE AMOUNT OF \$10,548.00 FOR UPGRADES TO THE POLICE MOBILE COMMAND CENTER; AUTHORIZING CITY MANAGER TO EXECUTE CONTRACTUAL DOCUMENTS, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY FOR THE CONTEMPLATED UPGRADES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the "City") Police Department has requested certain upgrades be performed to the City's new mobile command vehicle, which are essential to provide command and control at major events and/or emergency situations; and

**WHEREAS**, these upgrades will enhance the communications, computer technology and work space within the new mobile command vehicle.

**WHEREAS**, in order to accomplish the updates to the command vehicle, staff has recommended the City Council approve an increase in purchase order #20150173 with LDV, Inc. in the amount of \$10,548.00, to be funded from the Law Enforcement Trust Fund ("LETF").

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval of Purchase Order Increase.** The increase of purchase order #20150173 for upgrades being done to the new mobile command vehicle in the amount of \$10,548.00 is hereby approved. It is acknowledged that such

increase is being funded from the Law Enforcement Trust Fund (LETF) received through the Department of Justice (DOJ). Expense will be expended through account 105.60005.500640.

**Section 3. Authorization.** The City Manager is authorized to execute such contractual documents, subject to approval as to form and legal sufficiency, as may be needed to accomplish the increase in the purchase order for the upgrades contemplated herein.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such additional action as may be necessary to implement the purpose and provisions of this resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Ruiz who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:
