

**RESOLUTION No.15-71**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A TABLE SPONSORSHIP FOR THE WORLDCITY GLOBAL CONNECTIONS AND TRADE CONNECTIONS EVENT SERIES TAKING PLACE FROM MAY 2015 TO APRIL 2016; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN ACCORDANCE THEREWITH; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the WorldCity organization, a media company focused on international trade and specific communities' connections to the global economy, hosts a series of 16 Global Connections and Trade Connections ("Global Connections") events for the international business community and produces publications that focus on South Florida's multinational and trade industry, which includes many Doral businesses; and

**WHEREAS**, most of the WorldCity events are held in the City of Doral; and

**WHEREAS**, the City of Doral (the "City") approved an annual sponsorship at the \$4,500.00 level in May 2014 which will expire in April 2015; and

**WHEREAS**, participation by the City's Mayor and Council Members, Economic Development staff, and/or members of the Economic Development Advisory Board has reinforced the City's commitment to promoting its stature as an international trade, logistics and multinational business hub; and

**WHEREAS**, renewed sponsorship of the 16 WorldCity events for 2015-16 aligns with the City's economic development aspirations; and

**WHEREAS**, the Table Sponsorship package at the \$4,500 level consists of the following: Six (6) seats to each Global Connections and Trade Connections events, a total of 96 seats at 16 events from May 2015 through April 2016; City of Doral's logo in all e-mail invitations; Quarter-Page Ad in event Programs; Table signage at each event; and

**WHEREAS**, the Mayor and City Council believe that this sponsorship will advance, and otherwise be in the best, interests of the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The Global Connections and Trade Connections Sponsorship Package, in the amount of \$4,500.00, in accordance with the World City Invoice, which is attached hereto as Exhibit "A" and incorporated herein and made a part hereof by this reference, is hereby approved.

**Section 3. Authorization.** The City Manager is hereby authorized to expend funds in furtherance of the approved sponsorship and to executed appropriate documentation to formalize the sponsorship, subject to approval as to form and legal sufficiency by the City Attorney.


**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such additional action as may be necessary to implement the purpose and provision of this Resolution.
