

**RESOLUTION No. 13-45**

**RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO A JOINT PARTICIPATION AGREEMENT (JPA) WITH MIAMI-DADE COUNTY AND OTHER INVOLVED PARTIES TO COMPLETE THE PROJECT LOCATED AT NW 97 AVENUE FROM NW 70 STREET TO NW 74 STREET AT A COST OF \$1.5 MILLION; THE CITY IS TO ADVANCE THE COST OF SAID PROJECT AND THE COUNTY IS TO REIMBURSE THE CITY FOR THE TOTAL AMOUNT SPENT IN QUARTERLY INSTALLMENTS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Transportation Planning Council (TPC) recommended approval of amendments to the 2035 Long Range Transportation Plan (LRTP) advancing to Priority I of the Plan of Project from Miami-Dade County Public Works and Waste Management Department (PWWMD); and

**WHEREAS**, the Transportation Planning Council (TPC) has recommended approval of amendments to the 2013 Long Range Transportation Plan (LRTP) advancing to Priority I of the Plan project from the Miami-Dade Public Works and Waste Management Department (PWWMD) and

**WHEREAS**, the City of Doral has developed a series of priority public works projects that would help resolve the existing traffic problems within the city; and

**WHEREAS**, one of the City's projects, specifically, N.W. 97th Avenue from N.W. 70th Street to N.W. 74th Street reconstruction is one of the projects approved in the Priority 1 of the Plan; and

**WHEREAS**, the estimated cost of the project is approximately \$1.5 million; and

**WHEREAS**, the City of Doral would advance amount of money toward said construction; and

**WHEREAS**, Miami-Dade County will reimburse the City for all amounts advanced; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into a Joint Participation Agreement (JPA) with Miami Dade County and other involved parties to complete said project at N. W.97th Avenue from N.W. 70th Street to N,W. 74th Street - road construction.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The above recitals are true and correct and are incorporated herein by reference.

**Section 2.** The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into a JPA with Miami-Dade County and other involved parties to complete the project at N.W. 97th Avenue from N.W. 70th Street to N.W. 74th Street - road construction.

**Section 3.** The City Council approves advancing sufficient funds to pay for said construction.


**Section 4.** Miami-Dade County would reimburse 100% of the City's expenditures in the above-captioned project.
