## **RESOLUTION No. 17-54**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE PAYMENT OF PREFERRED GOVERNMENTAL INSURANCE TRUST FINAL AUDIT INVOICE IN AN AMOUNT NOT TO EXCEED \$44,838.00 FOR THE CITY'S GENERAL LIABILITY, AUTO LIABILITY, AUTO PHYSICAL DAMAGE, PROPERTY AND WORKERS COMPENSATION INSURANCE COVERAGE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Preferred Governmental Insurance Trust (PGIT) is the City of Doral's (the "City") current insurance provider during FY 2016-2017; and

**WHEREAS**, as part of the provider process for workers compensation insurance, after year-end, an audit is performed to determine the proper amount to charge for coverage based on actuals; and

WHEREAS, after the FY 2015-2016 audit, PGIT's final premium invoice due is \$44,838.00; and

**WHEREAS**, staff has recommended payment of the final premium, payable from the General Government fund, Workers Compensation account # 001.50005.500240, with a transfer from account #001.50005.500450.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> Authorization. The City Council hereby authorizing the payment of the outstanding invoice with Preferred Governmental Insurance Trust (PGIT) in an amount not to exceed \$44,838.00, from the General Government fund, Workers

Compensation account # 001.50005.500240, with a transfer from account #001.50005.500450.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
