

RESOLUTION No.16-31

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE AWARD OF ITB#2015-39 “WIRING SERVICES FOR THE CITY'S DATA INFRASTRUCUTURE” TO STUCTURE CABLING SOLUTIONS, INC.; AUTHORIZING THE CITY MANAGER TO ENTER INTO A THREE (3) YEAR AGREEMENT WITH THE OPTION TO RENEW THE CONTRACT FOR AN ADDITIONAL TWO (2) YEAR PERIOD; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the “City”) issued Invitation To Bid #2015-39, “Telecommunications Wiring Services” (the “ITB”) on November 7, 2015 for the purchase of wiring services for the City’s data infrastructure, for which three (3) submittals were received and opened by the November 24, 2015 deadline; and

WHEREAS, of the submittals received, Structured Cabling Solutions, Inc. (“SCS”) submitted the only fully responsive bid and was found to be the lowest, most responsible and responsive bidder; and

WHEREAS, staff has recommended the City Council award the ITB to SCS and authorize the Manager to negotiate and enter into an agreement with SCS for the purchase of on-going wiring services for the City’s data infrastructure, procured on a work-order basis.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval of Award. The award of the Invitation To Bid #2015-39, “Telecommunications Wiring Services” is hereby awarded to Structured Cabling

Solutions, Inc., subject to the entering into an agreement with the City on the same or substantially similar terms as presented in SCS's submittal. The award of the ITB does not in and of itself constitute a vested contractual right to SCS.

Section 3. Authorization. The City Manager is hereby authorized to negotiate and execute such agreements and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to procure purchase of wiring services for the City's data infrastructure, and to expend budgeted funds therefor. It is acknowledged that purchases shall be made by individual work orders in accordance with spending limits specified in the City Code.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Ruiz who moved its adoption.
