

**BILL OF SALE**

This Bill of Sale is made on the 3 day of September, 2014 between the City of Doral, a Florida municipal corporation having its principal place of business at 8300 NW 53 Street, #100, Doral, Florida 33166 (hereinafter "City") and Brink's US, a division of Brink's, Inc., a Florida corporation having its principal place of business at 5575 NW 87<sup>th</sup> Avenue, Doral, Florida 33166 (hereinafter "Brinks").

WHEREAS, in May 2009, Brinks donated a 1990 International, Model #4700, VIN #1HTSCZWM5LH277783 to the City by and through a Declaration and Acceptance of Gift; and

WHEREAS, the terms of the Declaration and Acceptance of Gift state that should the City no longer have a need for the vehicle, that the vehicle will be returned to Brink's in an "AS IS" condition; and

WHEREAS, City no longer has a need for the vehicle and, therefore, wishes to abide by the terms of the Declaration and Acceptance of Gift by returning the vehicle to Brinks; now, therefore

IN CONSIDERATION of the mutual covenants and conditions herein expressed and the faithful performance of all such covenants and conditions the undersigned parties do mutually agree as follows:

- (1) Brinks agrees to pay City one dollar (\$1.00) for the purchase of the 1990 International, Model #4700, VIN #1GRAXQN5KG277783 in "AS IS" condition.
- (2) Brinks acknowledges and accepts the 1990 International in its present "AS IS" condition.
- (3) City agrees to vest all incidents of absolute ownership and liability in said property in Brinks from this date forward.
- (4) City agrees to relinquish all rights to the vehicle to Brinks.

(5) Brinks does hereby release and hold the City, its agents, officers and employees, harmless from all claims, actions and causes of action, damages, losses and liabilities, costs or expenses whatsoever arising out of the sale of the vehicle.

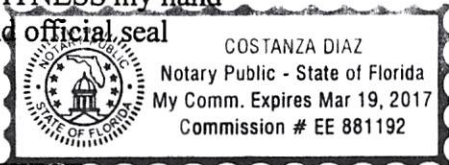

**RESOLUTION NO. 14-100**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF  
THE CITY OF DORAL, FLORIDA, APPROVING BILL OF SALE  
TRANSFERRING GIFTED ARMORED VEHICLE BACK TO  
BRINK'S FOR NOMINAL FEE; PROVIDING FOR

**WHEREAS**, in May of 2009 Brink's U.S., a division of Brink's Inc. ("Brink's"), donated a 1990 International Armored Vehicle, Model #4700, VIN #1HTSCZWM5LH277783 (the "Vehicle"), to the City of Doral (the "City") by and through a Declaration and Acceptance of Gift; and

**WHEREAS**, the terms of the Declaration and Acceptance of Gift state that should the City no longer have a need for the Vehicle, that the Vehicle will be returned to Brink's in an "AS IS" condition; and

**WHEREAS**, the City no longer has a need for the Vehicle and, therefore, wishes to abide by the terms of the Declaration and Acceptance of Gift by returning the vehicle to Brinks.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval of Transfer and Bill of Sale.** The transfer of the Vehicle back to Brink's is hereby approved. The bill of sale accomplishing the transfer of the Vehicle, attached hereto as Exhibit "A" and incorporated herein and made a part hereof by this reference (the "Bill of Sale"), is hereby approved.

**Section 3. Implementation.** The City Manager is hereby authorized to execute the Bill of Sale and such other purchase orders, agreements, and/or other documents, after approval as to form and legal sufficiency by the City Attorney, and to take such other action as is necessary to implement the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.



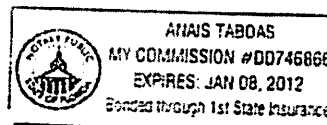

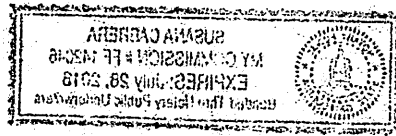

**WHEREAS, Brink's US is offering the City of Doral a donation of one (1) vehicle;**

**WHEREAS, the City recognizes that should there no longer be a need for this vehicle, it is to be returned in "as is" condition; and**
