

RESOLUTION No.13-62

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MAGGOLC, INC. FOR THE PROVISION OF PERFORMING CITY WIDE INFRASTRUCTURE IMPROVEMENTS TO THE DORAL TROLLEY SYSTEM IN AN AMOUNT NOT TO EXCEED \$234,514.50 INCLUDING A 10% CONTINGENCY; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to Invitation to Bid #2013-05 titled "Doral Trolley Infrastructure Improvements - City Wide," the City of Doral received four (4) bids by the April 8th, 2013 deadline; and

WHEREAS, upon careful review of the bids, Staff determined that that Maggolc, Inc. was the lowest most response, responsible bidder; and

WHEREAS, Staff respectfully requests that the City Council authorize the City manager to negotiate and enter into an agreement with Maggolc, Inc., for the provision of performing the city wide infrastructure improvements to the Doral Trolley System in an amount not to exceed \$234,514.50 including a 10% contingency; and

WHEREAS, Staff further requests that the City Council authorize the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Maggolc, Inc., for the provision of performing the city wide infrastructure improvements to the Doral Trolley System in an amount not to exceed \$234,514.50 including a 10% contingency.

Section 2. The City Council further authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreements approved herein.

Section 3. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Vice Mayor Rodriguez Aguilera who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:
