

**RESOLUTION No. 22-227**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, CERTIFYING AND DECLARING THE RESULTS OF THE GENERAL AND SPECIAL ELECTION HELD ON NOVEMBER 8, 2022, AND THE RUN-OFF ELECTION HELD ON DECEMBER 13, 2022; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, a General and Special Election were held in the City of Doral, Florida in accordance with the law on November 8, 2022 for the purpose of electing a Mayor, a Councilmember for Seat 1, a Councilmember for Seat 2 and a Councilmember for Seat 4; and

**WHEREAS**, the General Election resulted in a winner for the Councilmember for Seat 4, and due to the other races not having candidates who received more than 50% plus one (1) votes in this election, a Run-Off Election was necessary to determine a winner for the Mayoral Seat, Councilmember Seat 1 and Councilmember Seat 2; and

**WHEREAS**, the Miami-Dade County Canvassing Board has canvassed the votes cast in said election; and

**WHEREAS**, a Run-Off Election was held in the City of Doral, Florida in accordance with the law on December 13, 2022 for the purpose of electing an individual for the Mayoral Seat, Councilmember Seat 1 and Councilmember Seat 2; and

**WHEREAS**, the City of Doral Canvassing Board has canvassed the votes cast in said election.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

**Section 2. General and Special Election Results.** The City Council of the City of Doral, Florida, finds that after the canvassing of the votes cast in the General and Special Election held on November 8, 2022, that the results are as follows:

**Section 4. **Section 5. Declaration – Councilmember Seat 1.** The City Council of the City of Doral, Florida hereby declares that RAFAEL PINEYRO has been elected in accordance with the laws of the State of Florida and the Charter of the City of Doral to Councilmember Seat 1 Commencing December 14, 2022, after having obtained the highest number of votes cast in the Runoff Election on December 13, 2022.

**Section 6. Declaration – Councilmember Seat 2.** The City Council of the City of Doral, Florida hereby declares that MAUREEN PORRAS has been elected in accordance with the laws of the State of Florida and the Charter of the City of Doral to Councilmember Seat 2 Commencing December 14, 2022, after having obtained the highest number of votes cast in the Runoff Election on December 13, 2022.

**Section 7. Declaration – Councilmember Seat 4.** The City Council of the City of Doral, Florida hereby declares that DIGNA CABRAL has been elected in accordance with the laws of the State of Florida and the Charter of the City of Doral to Councilmember Seat 4 Commencing November 9, 2022, after having obtained the highest number of votes cast in the General Election on November 8, 2022.

**Section 8. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Pineyro who moved its adoption. The motion was seconded by Councilmember Porras and upon being put to a vote, the vote was as follows:
