

**RESOLUTION Z05-37**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE FINAL PLAT OF LAKES EDGE COMMERCIAL, GENERALLY LOCATED IN CLOSE PROXIMITY TO THE CITY OF DORAL'S SOUTHERN BOUNDARY, IN THE "FINGER LAKE" AREA, WEST OF NW 89 COURT, NORTH OF NW 13 TERRACE, APPROXIMATELY ONE BLOCK NORTH OF NW 12 STREET, IN THE CITY OF DORAL, MIAMI-DADE COUNTY, FLORIDA; PROVIDING FOR RECORDATION; PROVIDING AN EFFECTIVE DATE**

WHEREAS, Lakes Edge Commercial Properties, LLC ("Applicant"), has requested final plat approval for Lakes Edge Commercial, as described in Exhibit "A" attached hereto, generally located in close proximity to the City of Doral's southern boundary, in the "finger lake" area, west of NW 89 Court, north of NW 13 Terrace, approximately one block north of NW 12 Street, in the City of Doral, Miami-Dade County, Florida; and

WHEREAS, the Miami-Dade County Plat Committee has reviewed this application and has recommended same for approval; and

WHEREAS, this application has been reviewed for compliance with Chapter 28 of the Miami-Dade County Code by staff and a Professional Surveyor and Mapper employed by Miami-Dade County and same has been found to be consistent; and

WHEREAS, after careful review and deliberation, staff has determined that this application has complied with the Code;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:**

**Section 1.** The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

**Section 2.** The City Council of the City of Doral hereby approves the final plat of Lakes Edge Commercial, generally located in close proximity to the City of Doral's southern boundary, in the “finger lake” area, west of NW 89 Court, north of NW 13 Terrace, approximately one block north of NW 12 Street, in the City of Doral, Miami-Dade County, Florida.

**Section 3.** This Resolution shall be recorded in the Public Records of Dade County, Florida, with the Applicant to pay the costs thereof.

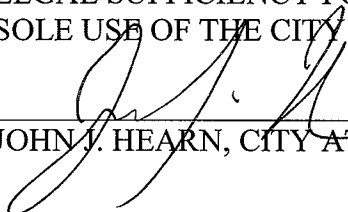
