A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF THE INVITATION TO BID #2015-21 "BROADCAST PIX MICA VIDEO PRODUCTION SYSTEM" TO TECHNO SYSTEMS; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH TECHNO SYSTEMS, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE AND INSTALLATION OF A BROADCAST PIX MICA VIDEO PRODUCTION SYSTEM, IN AN AMOUNT NOT TO EXCEED \$32,695.00, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 8, 2015, the City of Doral (the "City") issued Invitation to Bid #2015-20 for "Broadcast Pix Mica Video Production System" (the "ITB") for the purchase and installation of certain equipment, for the City's information technology infrastructure; and

WHEREAS, in response to the ITB, three (3) firm attended the mandatory pre-bid meeting held on July 15, 2015 and the City received two (2) submittals by the advertised deadline, of which Techno Systems was one; and

WHEREAS, Techno Systems was found to be the lowest, most responsible and most responsive bidder; and

WHEREAS, staff has recommended the Mayor and City Council authorize the City Manager to enter into agreement with Techno Systems for the purchase and installation of Broadcast Pix Mica Production System, in an amount not to exceed \$32,695.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval of Award. The award of the Invitation to Bid #2015-21 "Broadcast Pix Mica Production System" is hereby awarded to Techno Systems, subject to the entering into an agreement with the City on the same or substantially similar terms as presented in Techno System's submittal. The award of the ITB does not in and of itself create or confer a vested contractual right to Techno Systems.

Section 3. Authorization. The City Manager is hereby authorized to execute such agreements and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to procure the equipment and installation of Broadcast Pix Mica Video Production System, in an amount not to exceed \$32,695.00. The City Manager is authorized to expend budgeted funds in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
