

RESOLUTION NO. 13-94

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH KING ENGINEERING ASSOCIATES, INC. TO PROCEED WITH THE SURVEYING & MAPPING OF STORMWATER DRAINAGE INFRASTRUCTURE IN SECTION 22, IN AN AMOUNT NOT TO EXCEED \$43,770.00; AND PROVIDING FOR AN EFFECTIVE DATE (PUBLIC WORKS)

WHEREAS, the City of Doral Public Works Department wishes to secure a firm to survey and map in detail the City of Doral Stormwater Drainage Infrastructure in Section 22 of the City; and

WHEREAS, King Engineering Associates, Inc., is a prequalified provider of professional services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in September 2011. Following a review of the experience and qualifications for the pool of prequalified firms, it was determined that King Engineering Associates, Inc., has relevant experience to perform the survey work; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to direct King Engineering Associates, Inc., to proceed with the Surveying & Mapping of Section 22; in an amount not to exceed \$43,770.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Authorization. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with King Engineering Associates, Inc., to perform the Surveying & Mapping of stormwater drainage infrastructure in Section 22 in an amount not to exceed \$43,770.00.

Section 2. **Effective Date.** This Resolution shall take effect immediately upon adoption.


