

RESOLUTION No. 08 – 23

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI DADE COLLEGE INSTITUTE OF CRIMINAL JUSTICE FOR THE PROVISION OF IN-SERVICE TRAINING AND RECERTIFICATION OF ALL NEWLY-HIRED SWORN CITY OF DORAL POLICE DEPARTMENT PERSONNEL IN AN AMOUNT NOT TO EXCEED \$33,637.50; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral City Council seeks to meet the immediate needs of the newly-formed City of Doral Police Department; and

WHEREAS, The City of Doral Police Department is scheduled to commence operations during the Summer 2008 and its' newly-hired sworn personnel will require in-service training and recertification; and

WHEREAS, the State of Florida Department of Education pays equal matching funds to Miami Dade College for in-service training and recertification; and

WHEREAS, because this service is unique in nature and urgently needed, Staff respectfully requests that Council waive the bidding requirements consistent with Section 12 – 9 of the City of Doral Purchasing Ordinance and authorize the City Manager to negotiate and enter into an agreement with Miami Dade College Institute of Criminal Justice for the provision of in-service training and recertification of all newly-hired sworn City of Doral Police Department personnel in an amount not to exceed \$33,637.50.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby waives the bidding requirements and authorizes the City Manager to negotiate and enter into an agreement with Miami Dade College Institute of Criminal Justice for the provision of in-service training and recertification of all newly-hired sworn City of Doral Police Department personnel in an amount not to exceed \$33,637.50.

Section 2. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilman DiPietro who moved its adoption. The motion was seconded by Councilwoman Ruiz and upon being put to a vote, the vote was as follows:

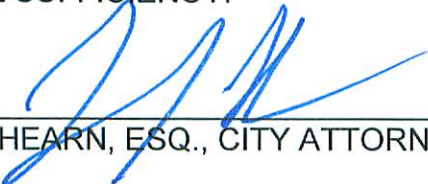
