

RESOLUTION NO. 13-68

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA PURSUANT TO SECTION 2-322 OF THE CITY CODE, ADOPTING THE EXISTING AGREEMENT BETWEEN KELLY TRACTOR AND FLORIDA SHERIFFS ASSOCIATION, FLORIDA ASSOCIATION OF COUNTIES AND FLORIDA FIRE CHIEFS ASSOCIATION, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY CODE, FOR THE PROVISION OF A 2013 NISSAN CFS40 5000LB PNEUMATIC LIFT TRUCK IN AN AMOUNT NOT TO EXCEED \$27,995.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department has budgeted for the purchase of a Forklift for Fiscal Year 2012-2013. The Public Works Department seeks to purchase a forklift to be used by the Construction Division and other departments, for the loading and un-loading of equipment, materials, supplies, pallets and other uses as needed; and

WHEREAS, Kelly Tractor has an existing contract with the Florida Sheriffs Association, Florida Association Of Counties And Florida Fire Chiefs Association (Contract #12-10-0905) which was competitively procured for the provision of a Nissan cfs40 5000lb Pneumatic Lift Truck; and

WHEREAS, Pursuant to Section 2-322 of the City Code, Staff Respectfully Requests that the City Council adopt the existing agreement between Kelly Tractor and Florida Sheriffs Association, Florida Association Of Counties and Florida Fire Chiefs Association, which was competitively entered into in a manner similar to that set forth In Chapter 2, Article V, Of The City Code for the provision of a 2013 Nissan cfs40 5000lb Pneumatic Lift Truck in an amount not to exceed \$27,995.00, and further requests that the City Council authorize the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:


Section 1. The City Council of the City of Doral Florida authorizes the adoption of the existing agreement between Kelly Tractor and Florida Sheriffs Association, Florida Association Of Counties And Florida Fire Chiefs Association, which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code, for the provision of a 2013 Nissan cfs40 5000lb Pneumatic Lift Truck in an amount not to exceed \$27,995.00, and further authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.
