WHEREAS, the City of Doral Public Works Department seeks to transfer funds to cover the interest and principal payments for Doral Trolley No. 4.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby authorizes the City Manager to transfer funds from the Transportation Fund Contractual Services account No. 101.80005.500341 in the amount of \$3,445.20 to the Transportation Fund Debt Service Interest Account No. 101.80005.500720 for the provision of scheduled interest payments for Doral Trolley No. 4 during Fiscal year 11-12.

Section 2. The City Council of the City of Doral, Florida further authorizes the City Manager to transfer funds from the Transportation Fund Contractual Services Account No. 101.80005.500341 in the amount of \$48,360.18 to the Transportation Fund Debt Services Principal Account No. 101.80005.500710 for the provision of principal payments scheduled for Doral Trolley No. 4 during Fiscal Year 11-12.
