A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ZAMBELLI INTERNATIONALLE, INC. FOR THE PROVISION OF A FIREWORKS DISPLAY FOR THE CITY OF DORAL INDEPENDENCE DAY CELEBRATION ON JULY 4TH, 2008 IN AN AMOUNT NOT TO EXCEED \$42,500.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City of Doral seeks to provide a safe and high-quality fireworks display in celebration of our nation's Independence Day; and

WHEREAS, Zambelli Internationalle, Inc has, for the past three (3) years, provided to the City of Doral a safe and high quality fireworks display for the City's Independence Day celebrations; and

WHEREAS, due to the uniqueness of the service, the long history of Zambelli Internationalle, Inc. which has been in the fireworks display business for over 100 years, and the consistently high-quality product they have provided the City, Staff respectfully requests that the City Council waive the Request for Proposals (RFP) process and authorize the City Manager to negotiate and enter into an agreement with Zambelli Internationalle, Inc. for the provision of a fireworks display for the City of Doral Independence Day Celebration on July 4th, 2008 in an amount not to exceed \$42,500.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby waives the RFP process and authorize the City Manager to negotiate and enter into an agreement

with Zambelli Internationalle, Inc. for the provision of a fireworks display for the City of Doral Independence Day Celebration on July 4th, 2008 in an amount not to exceed \$42,500.00.

Section 2. This Resolution shall take effect immediately upon adoption.
