A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY TO ENTER INTO A CONTRACT WITH EB DEVELOPERS, INC. TO PERFORM ENGINEERING AND ENVIRONMENTAL CONSULTING SERVICES FOR THE EXTENSION OF NW 107TH AVENUE FROM THEORETICAL NW 67TH STREET TO 71ST STREET: THE COMPETITIVE WAIVING **BIDDING** PROCEDURES TO CAPITALIZE ON ECONOMIES OF SCALE AND SAVING MONEY WHILE EXPEDITING THE COMPLETION OF THIS PROJECT; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City is making any and all efforts to expedite the engineering and construction of the NW 107th Avenue extension in order to assist in much needed traffic flow in the City; and

WHEREAS, EB Developers, Inc. is currently working on nearby sections of NW 107th Avenue to the south of the portion of the roadway that the City is in need of extending; and

WHEREAS, by hiring EB Developers, Inc. for the cost estimate which was provided to the City Council at the May 9, 2007 meeting, the City can capitalize on economies of scale and save money while also expediting the completion of this much needed project; now, therefore

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

<u>Section 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

Section 2. The City Council of the City of Doral hereby authorizes the City Manager to enter into an Agreement with EB Developers, Inc. to perform engineering and environmental consulting services for the extension of NW 107th Avenue from theoretical NW 67th Street to 71st Street, consistent with the cost estimates that were prepared by EB Developers, Inc. and provided to the City Council at its May 9, 2007 meeting.

<u>Section 3.</u> Consistent with Section 12-9 of the City's Purchasing Ordinance, the City Council hereby waives the competitive bidding procedures due to economies of scale and efficiency of time.

<u>Section 4.</u> This resolution shall become effective upon its passage and adoption by the City Council.
