

**RESOLUTION NO. 14-33**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA PROVIDING FOR AN AMENDMENT TO THE EXECUTED PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF DORAL AND WOLFBERG, ALVAREZ & PARTNERS, INC. TO INCLUDE LEED/SUSTAINABILITY CONSULTING SERVICES FROM SEQUIL SYSTEMS, INC.; FURTHER AMENDING ADOPTED RESOLUTION NO. 14-15 AND PROFESSIONAL SERVICES AGREEMENT BY INCREASING THE TOTAL CONTRACT AMOUNT IN THE AMOUNT OF \$52, 435, FROM \$310,460 TO AN AMOUNT NOT TO EXCEED \$362,895; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on January 15, 2014, Council adopted Resolution No. 14-15 (see "Attachment A") authorizing the City Manager to negotiate a Professional Services Agreement for architectural and engineering services for the Police Facility Expansion Project with the top ranked firm, Wolfberg, Alvarez & Partners, Inc. in an amount not to exceed \$310,460; and

**WHEREAS**, Council requested that the Building Department pursue LEED Certification Consulting Services for this Project; and

**WHEREAS**, upon careful review, the Building Department is recommending that the original firm used to LEED certify the building be used for the Project; and

**WHEREAS**, staff is respectfully requesting that the City Council authorize the amendment to the executed Professional Services Agreement between the City of Doral and Wolfberg, Alvarez & Partners, Inc. to include LEED/Sustainability Consulting Services from Sequil Systems, Inc. with the terms, conditions, and pricing stipulated in "Attachment C".

**WHEREAS**, it is also requested that the adopted Resolution No. 14-15 and executed Professional Services Agreement be amended to increase the contract amount in the amount of \$52,435, from \$310,460 to an amount not to exceed \$362,895; and

**WHEREAS**, funding for this agreement is available in Account No. 001.6005500.621.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby authorizes the amendment to the executed Professional Services Agreement between the City of Doral and Wolfberg, Alvarez & Partners, Inc. to include LEED/Sustainability Consulting Services from Sequil Systems, Inc. for the Police Expansion Project; furthermore amending adopted Resolution No. 14-15 and Professional Services Agreement by increasing the total contract amount in the amount of \$52,435, from \$310,460 to an amount not to exceed \$362,895; and providing for an effective date.

**Section 2.** This Resolution shall take effect immediately upon adoption.
