

RESOLUTION No.13-97

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE RANKINGS OF THE SUBMITTED PROPOSALS IN RESPONSE TO RFP #2013-18 TITLED "GARAGE CAMERA INSTALLATION;" AUTHORIZING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE TOP-RANKED FIRM, JOHNSON CONTROLS, INC. FOR THE INSTALLATION OF GARAGE CAMERAS IN THE CITY'S PARKING GARAGE IN AN AMOUNT NOT TO EXCEED \$52,465.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to Request for Proposals (RFP) #2013-18 titled "Garage Camera Installation," the City of Doral received seven (7) proposals by the August 23rd, 2013 deadline; and

WHEREAS, upon careful review of the proposals, the selection committee ranked Johnson Controls, Inc. as the most responsive, responsible proposer; and

WHEREAS, Staff respectfully requests that the City Council approve the selection committee's ranking of the submitted proposals in response to RFP #2013-18 and authorize the City Manager and the City Attorney to negotiate and enter into an agreement with Johnson Controls, Inc., as the top-ranked firm, for the installation of garage cameras in the City's parking garage in an amount not to exceed \$52,465.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Rankings. The City Council hereby approves the selection committee's ranking of the submitted proposals in response to RFP #2013-18 titled "Garage Camera Installation."

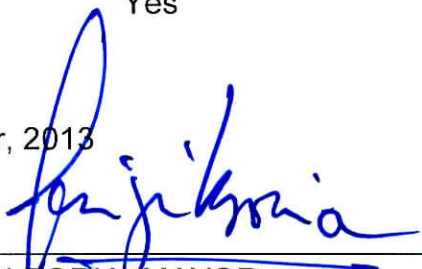
Section 3. Authorization. The City Council authorizes the City Manager and the City Attorney to negotiate and enter into an agreement with Johnson Controls, Inc., as the top-ranked firm, for the installation of garage cameras in the City's parking garage in an amount not to exceed \$52,465.00, and authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

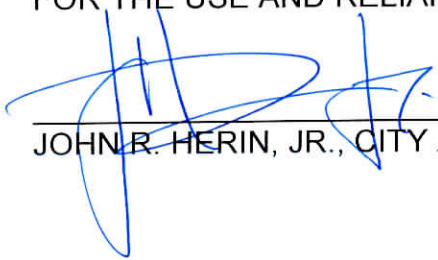
