

RESOLUTION No. 24-171

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY RUBEN FIGUEREDO, PRESIDENT OF SKATE WITH US LLC ON SUNDAY, OCTOBER 13, 2024 AT 6550 NW 97 AVE DORAL, 33178; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Ruben Figueredo, (the “Applicant”) seeks approval from the City of Doral of a special event permit to host the “Skate with US Marathon” (the event) at 6650 NW 97 Avenue, Doral; and

WHEREAS the purpose of the “Skate with US Marathon” event is to promote inline skating and provide the opportunity to the Doral Community to enjoy this unique sport event and showcase the City of Doral as a sport enthused City; and

WHEREAS, the event will promote an active lifestyle, which is in line with the City of Doral’s fitness initiatives; and

WHEREAS, staff recommends that the Mayor and City Council approve with conditions the proposed special event permit to host the “Skate with Us Marathon” event at 6550 NW 97 Avenue, Doral, FL 33178, on Sunday, October 13, 2024, from 6:00 a.m. to 12:00 p.m. Set up time will start at 6:00 a.m., the event is scheduled to start at 7:00 a.m. and the tear down will conclude at 12 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The special event permit for the “Skate with Us Marathon”; is hereby approved subject to the following conditions:

1. Applicant shall submit Maintenance of Traffic (“MOT”) Plan to the City Planning and Zoning Department for review and by the Public Works Department and the Police Department no later than ninety (90) days prior to the scheduled event.
2. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
3. The Applicant shall be required to have all inspections and approvals prior to the event date.
4. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
5. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes.
6. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
7. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
8. The Applicant shall provide to the City of Doral an acceptable certificate of insurance four weeks prior to the event date.
9. If applicable, the Applicant shall provide to the City of Doral a copy of the parking agreement thirty (30) days prior to event start date.
10. If applicable, the Applicant shall secure a maintenance of traffic (MOT) permit from the City of Doral Public Works Department and/or Miami-Dade County Department of Transportation and Public Works prior to event start date.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Pineyro who moved its adoption. The motion was seconded by Vice Mayor Puig-Corve and upon being put to a vote, the vote was as follows:
