

**RESOLUTION No. 20-01**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT FOR LOUD AND LIVE, INC, TO HOST THE “2020 DOWNTOWN DORAL COMMUNITY FEST” EVENT AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166 ON SUNDAY, MARCH 1, 2020, FROM 7:30AM TO 1:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Loud and Live, Inc (“Applicant”) seeks approval from the City of Doral for a Special Event Permit; and

**WHEREAS**, the Loud and Live, Inc (“Applicant”) seeks approval from the City to use the City logo for branding purposes; and

**WHEREAS**, staff recommends Council to approve the proposed Special Event Permit to host the “2020 Downtown Doral Community Fest” Event on Sunday, March 1, 2020, located at Downtown Doral Park, 8395 NW 53 Street, Doral, FL 33166.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The Special Event Permit for the “2020 Downtown Doral Community Fest” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department.
2. Applicant shall comply with the comments made by the City of Doral Police Department.
3. Applicant shall comply with all Building Permits and inspections required by the Building Department prior to the event start date.
4. Applicant shall acquire MOT Permit with the Public Works Department prior

to the event start date.

5. Applicant is responsible to pay all outstanding City fees prior to the issuance of the Special Event Permit.
6. The Event shall conclude at 1:00 PM.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
