

**RESOLUTION NO. 21-48**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPLICATION TO THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT COUNTYWIDE OFFICER SAFETY WELLNESS PROGRAM FOR GRANT FUNDS IN THE AMOUNT OF \$6,788.00 (REIMBURSABLE), AND AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN THE AMOUNT NOT TO EXCEED \$6,788.00, FOR THE PURCHASE OF TRAINING EQUIPMENT; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department has been awarded \$6,788.00 from the Edward Byrne Justice Assistance Grant-County-Wide (JAGC) Program as a reimbursable grant and expend funds from the Operating Supplies Account (001.60005.500520) in an amount not to exceed \$6,788.00, which will be used to purchase punching bags, wall mounts/bags stands etc. to enhance training and ensure our police officers are in good physical shape; and

**WHEREAS**, Staff respectfully requests that the Mayor and City Council authorize the application to the JAGC Program for grant funds in the amount of \$6,788.00 as a reimbursable grant and expend funds from the Operating Supplies Account (001.60005.500520) in an amount not to exceed \$6,788.00 to purchase punching bags, wall mounts/bags stands etc. to enhance training and ensure our police officers are in good physical shape; and

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager is hereby authorizes the application to the JAGC Program for grant funds account 001.6000.334200 in the amount of \$6,788.00 reimbursable grant and expend funds from Operating Supplies Account 001.60005.500520 in the amount of \$6,788.00 to purchase punching bags, wall mounts/bags stands etc. to enhance training and ensure our police officers are in good physical shape; and

**Section 3. Authorization:** The City Manager is hereby authorized to execute the application and expend funds (reimbursable) on behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
