



**RESOLUTION No. 16-39**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID #2015-41 FOR "POLICE UNIFORMS AND EQUIPMENT" TO GLOBAL TRADING, INC.; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GLOBAL TRADING, INC. FOR THE PROVISION OF POLICE UNIFORMS AND EQUIPMENT IN AN AMOUNT NOT TO EXCEED \$70,000.00; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department seeks to purchase Police Uniforms and Equipment; and

**WHEREAS**, as a result, on November 18, 2015, the City issued Invitation to Bid #2015-41, Police Uniforms and Equipment (the "ITB"), for which, after one hundred ninety-four (194) notices to firms were sent, four (4) bids were received and opened on the December 16, 2015 deadline; and

**WHEREAS**, Global Trading, Inc. was found to be the lowest, most responsible and responsive bidder; and

**WHEREAS**, staff has recommended the City award the ITB to Global Trading, Inc. and authorize the manager to negotiate and enter into an agreement with Global Trading, Inc. for the purchase of police uniforms and equipment, in an amount not to exceed \$70,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Award.** The ITB, for the provision of police uniforms and equipment for the police department, is hereby awarded to Global Trading, Inc. pursuant to the terms specified herein. This award does not confer any contractual rights on Global Trading, Inc.

**Section 3. Authorization.** The City Manager is authorized to negotiate and enter into agreement with Global Trading, Inc., subject to approval by the City Attorney as to form and legal sufficiency, to provide the Police Department with their police uniforms and equipment, in an amount not to exceed \$70,000.00, and on such other terms and conditions as may be in the best interest of the City. The City Manager is further authorized to expend budgeted funds from Operating Supplies account 001.60005.500520 on behalf of the City with respect to the agreement approved herein.


**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
