

**WORK ORDER No. 1 FOR PROFESSIONAL SERVICES**

The City of Doral authorizes the firm of Kimley-Horn and Associates, Inc. (Kimley-Horn) to provide professional engineering design and permitting services for the provision of roadway improvements along NW 102<sup>nd</sup> Avenue, NW 66<sup>th</sup> Street, and NW 99<sup>th</sup> Avenue. Where Kimley-Horn is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in October 2020 through Resolution 20-243. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Kimley-Horn and the City of Doral dated January 4, 2021, and the attached Proposal and submitted in March 2021 by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCEHDULE:**


The scope of the project will be as described in the attached proposal from Kimley-Horn for the design and permitting of the adjacent roads to the vacant parcel referenced by Folio No. 35-3017-001-0660, NW 102<sup>nd</sup> Avenue, NW 66<sup>th</sup> Street, and NW 99<sup>th</sup> Avenue. The schedule requires the scoped of work to be completed within 9 months of NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$232,083.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.


Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 4, 2021 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.





**RESOLUTION No. 21-100**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH KIMLEY-HORN AND ASSOCIATES, INC., TO PROCEED WITH PROFESSIONAL ENGINEERING SERVICES FOR THE DESIGN AND PERMITTING OF THE ROADWAY IMPROVEMENTS ALONG NW 102 AVENUE, NW 66 STREET, AND 99 AVENUE ABUTTING THE VACANT PARCEL REFERENCED BY FOLIO No. 35-3017-001-0660 IN AN AMOUNT NOT TO EXCEED \$232,083.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Miami-Dade County Solid Waste Department owns the vacant parcel located on the southeast corner of NW 102<sup>nd</sup> Avenue and NW 66<sup>th</sup> Street described by Folio No. 35-3017-001-0660; and

**WHEREAS**, the City of Doral has coordinated with Miami-Dade County Solid Waste Department for the dedication of the remaining 35 feet of right-of-way necessary to construct the full 70-foot right-of-way along the perimeter of the vacant parcel and match the surrounding intersecting roadways; and

**WHEREAS**, the Public Works Department (PWD) requested a proposal from Kimley-Horn and Associates, Inc. (Kimley-Horn) for the provision of the design and permitting of construction documents that would improve the subject corridors; and

**WHEREAS**, Kimley-Horn, is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2020 via Resolution No. 20-243; and

**WHEREAS**, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 1 for Kimley-Horn, a copy of which is attached hereto as Exhibit

“A”, for the provision of professional engineering services that include the design and permitting of the roadway improvements along NW 102<sup>nd</sup> Avenue, NW 66<sup>th</sup> Street, and NW 99<sup>th</sup> Avenue adjacent to Folio No. 35-3017-001-0660, on a time and material basis in an amount not to exceed amount of \$232,083.00, and

**WHEREAS**, funds for these services will be allocated from the current Fiscal Year Public Works Transportation Fund, Construction in Progress Account, Account No. 101.8000500.500650 and were included in the 2021 Budget Amendment presented at the April 2021 Council Meeting.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The Work Order between the City of Doral and Kimley-Horn and Associates, Inc. for the professional engineering services for the design and permitting of the roadway improvements along the subject corridors, in an amount not to exceed of \$232,083.00, a copy which is attached as Exhibit “A”, is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption.


