A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A TRANSFER OF \$1,300,000.00 FROM THE CAPITAL OUTLAY LAND ACCOUNT, #001.90005.500610 TO BE DISTRIBUTED INTO THE CAPITAL OUTLAY BUILDING ACCOUNT #001.90005.500620, PROFESSIONAL SERVICES ACCOUNT #001.90005.500310, AND THE KNIGHTS ART FOUNDATION ACCOUNT #001.90005.500496; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Transfer Authorized. The transfer of \$1,300,000.00 from the Capital Outlay Land Account #001.90005.500610, which will be distributed to the Capital Outlay Building Account #001.90005.500620, Professional Services Account #001.90005.500310, and Knight Art Foundation Account #001.90005.500496 to be used

for the construction of NW 114th Ave Park, revision of the Parks Master Plan, and matching grant funds for the Knight Foundation Grant is hereby approved.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
