

**RESOLUTION NO. 06 - 24**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE A CHANGE ORDER IN THE AMOUNT OF \$65,450.00 TO THE ILER PLANNING GROUP FOR ADDITIONAL SERVICES PROVIDED IN THE COMPLETION OF THE CONTRACT TO PREPARE THE COMPREHENSIVE DEVELOPMENT MASTER PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Resolution 04-39 authorized the City Manager to enter into an agreement with Iler Planning Group for the development of the Comprehensive Master Plan and Land Development Regulations; and

**WHEREAS**, it is now necessary to complete Tasks 1-12 through 1-14 of the original contract as specified in the letter from the Iler Planning Group hereunto attached as Exhibit "A."

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1.** The City Manager is hereby authorized to approve a change order in the amount of \$65,450.00 to Iler Planning Group contract for the development of a Comprehensive Master Plan and Land Development Regulations.


**Section 2.** This Resolution shall become effective immediately upon its adoption.



The purpose of this memorandum is the request an additional services cost authorization for our work late last fall and currently on-going to complete Tasks I-12 thru I-14 of the contract.


These additional services involve the following tasks:

- 7.) Monitor FDCA compliance review process following Plan adoption and transmittal, and give input as needed.
