RESOLUTION No. 17-34

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN EXTENSION OF THE CURRENT AGREEMENT WITH GARDEN STATE FIREWORKS, INC. FOR THE PROVISION OF THE CITY'S 4TH OF JULY FIREWORKS DISPLAY FOR A PERIOD OF ONE (1) YEAR TO COVER ONE (1) ADDITIONAL EVENT FOR THE 2017 INDEPENDENCE DAY CELEBRATION FIREWORKS DISPLAY IN AN AMOUNT NOT TO EXCEED \$45,000.00; AUTHORIZING THE CITY MANAGER TO EXECUTE A WRITTEN EXTENSION AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on April 9, 2014 the City Council approved Resolution # 14-59 authorizing the City Manager to enter into an agreement with Garden State Fireworks, Inc. for a period of one (1) year with two (2) additional one (1) year renewals for a possible total of three (3) years; and

WHEREAS, throughout the current contract period, Garden State Fireworks, Inc. Garden State Fireworks, Inc. has provided excellent service and has worked seamlessly with City staff in preparation for our annual Independence Day Celebration event under their contracted years, 2014, 2015 and 2016; and

WHEREAS, working with Garden State Fireworks, Inc. has been an essential component in facilitating the collaboration with the Federal Aviation Administration (the "FAA" and has served as a liaison between the City and the FAA to ensure the firework display was safely and efficiently conducted; and

WHEREAS, staff has recommended the extension of the current agreement for a period of one (1) year to cover one (1) additional event for the 2017 Independence Day Celebration Fireworks Display for an amount not to exceed \$45,000.00. This extension would allow the City to continue to grow and improve on the custom 4th of

July Fireworks Display that last 20-23 minutes during our immensely successful Independence Day Celebration event. All terms and conditions will remain the same during the extension term as in the original agreement which was entered on June 9, 2014; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby approves an extension to the current agreement with Garden State Fireworks, Inc. for the provision of the 4th of July Fireworks Display for a period of one (1) year to cover one (1) additional event for the 2017 Independence Day Celebration Fireworks Display in the amount of \$45,000.00.

Section 3. Authorization. The City Manager is hereby authorized to execute written extension and to expend budgeted funds in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
