TOTAL AMOUNT: \$17,949.50 (Not to exceed)

PROJECT SCOPE OF WORK: The City of Doral authorizes the firm of Rock Power Paving, Inc. to proceed with the restriping of NW 112th Ave (NW 50th Street to NW 58th Street), NW 80th Lane (NW 112th Ave to NW 111th Ct), in accordance with Contract specifications and in conformity with the lines, grades and dimensions of existing conditions. All road repairs will comply with Miami-Dade County Public Works Manual Part 2 Design and Construction Section 51, Limerock Base., Section 100, Prime and Tack Coats, Section 132, Asphaltic Concrete Binder Course, Section 133, Type S-I Asphaltic Concrete Surface Course. The scope of the project is described more fully in the Contract Documents, (ITB # 2009-21) "Remove / Replace Sidewalks, Curbs / Gutter and Resurfacing Bituminous Paving" the Agreement dated 14 January 2010.

If Contractor fails to execute said Work Order in a timely manner and complete all work within 30 calendar days from date of Pre Construction meeting, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

The performance of services associated with this Work Order will be executed on a 'Line Item' basis with a not to exceed amount of \$17,949.50

RESOLUTION No. 10 – 16

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ROCK POWER PAVING, INC. FOR THE PROVISION OF MILLING AND RESURFACING OF PUBLIC ROADS AND SIDEWALK REPAIRS IN PUBLIC CITY STREETS IN AN AMOUNT NOT TO EXCEED \$3,150,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to Invitation to Bid #2009-21 titled "Remove / Replace Sidewalks, Curbs / Gutter, Milling and Resurfacing of Bituminous Paving, " the City of Doral received five (5) bids by the December 29th, 2009 deadline; and

WHEREAS, upon careful review of the bids, Staff determined that that Rock Power, Inc. was the lowest most response, responsible bidder; and

WHEREAS, Staff respectfully requests that the City Council authorize the City manager to negotiate and enter into an agreement with Rock Power Paving, Inc., for the provision of milling and resurfacing of public roads and sidewalk repairs in public city streets in an amount not to exceed \$3,150,000.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Rock Power Paving, Inc., for the provision of milling and resurfacing of public roads and sidewalk repairs in public city streets in an amount not to exceed \$3,150,000.00.

Section 2. This Resolution shall take effect immediately upon adoption.
