

RESOLUTION NO. 09 – 43

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ACCEPTING THE AMERICAN REINVESTMENT AND RECOVERY ACT (STIMULUS) FUNDS IN THE AMOUNT OF \$776,997.00; AUTHORIZING THE CITY MANAGER TO EXPEND THESE FUNDS FOR THE CONSTRUCTION OF TWO ADDITIONAL LANES ON N.W. 33RD STREET FROM N.W. 92ND AVENUE TO N.W. 97TH AVENUE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral Public Works Department was notified that the American Reinvestment Recovery Act (Stimulus) has made funds available for eligible city projects; and

WHEREAS, the amount of \$776,997.00 was assigned to the City of Doral projects based upon the State and County formulas; and

WHEREAS, after identifying top priority projects, Staff respectfully requests that the City Council accept the American Reinvestment and Recovery Act funds in the amount of \$776,997.00 and authorize the City Manager to expend these funds for the construction of two additional lanes on N.W. 33rd Street from N.W. 92nd Avenue to N.W. 97th Avenue.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council hereby accepts the American Reinvestment and Recovery Act funds in the amount of \$776,997.00 and authorizes the City Manager to expend these funds for the construction of two additional lanes on N.W. 33rd Street from N.W. 92nd Avenue to N.W. 97th Avenue.

Section 2. This Resolution shall become effective immediately upon its adoption.
