The City of Doral authorizes the firm of A&P Consulting Transportation Engineers to provide professional engineering services for the Doral Congestion Management Plan – Phase III. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 20, 2015, and the attached Proposal submitted by your firm for the above referenced project.

## SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from A&P Consultant Transportation Engineers dated May 15, 2017 for the performance of the Doral Congestion Management Plan – Phase III. The schedule requires the signal retiming to be implemented within 90 calendar days of the notice to proceed and an additional 30 calendar day post implementation monitoring period. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$24,209.77.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 20, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.

## **RESOLUTION No. 17-117**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER FOR A&P CONSULTING TRANSPORTATION ENGINEERS, A PREQUALIFIED CITY VENDOR, FOR THE DEVELOPMENT OF FINE TUNED SIGNAL TIMING PLANS BASED ON FIELD OBSERVED PREVAILING TRAFFIC CONDITIONS FOR NW 25 STREET BETWEEN NW 89 PLACE AND NW 117 AVENUE, INCLUDING A FOUR-WEEK POST IMPLEMENTATION MONITORING PERIOD, IN AN AMOUNT NOT TO EXCEED \$24,209.77; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") currently experiences significant levels of congestion along its major arterials due to overwhelming vehicular demand; and

WHEREAS, the Miami-Dade County Traffic Control Center contains one of the country's largest centralized traffic signal control systems, which controls over 2,800 signalized intersections within the County; and

WHEREAS, as part of City Council's strategic priorities to reduce traffic congestion and improve travel times, the Public Works Department ("PWD") previously retained A&P Consulting Transportations Engineers ("A&P") for the plan development and signal retiming services for NW 36 Street between NW 87 Avenue and the Turnpike, NW 87 Avenue between SR 836 and NW 58 Street, and NW 107 Avenue between SR 836 and NW 90 Street which have been implemented by Miami-Dade County; and

WHEREAS, the PWD recommends the development of updated, fine-tuned signal timing plans based on prevailing observed traffic field conditions for Miami-Dade County's acceptance and implantation and four (4) weeks of post implementation traffic monitoring period for NW 25 Street between NW 89 Place and NW 117 Avenue; and

WHEREAS, A&P is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act requirements and approved by the City Council in December 2014; and

WHEREAS, the PWD has recommended that the City Council approve the Work Order with A&P, a copy of which is attached hereto as Exhibit "A", for the signal retiming services of NW 25 Street between NW 89 Place and NW 117 Avenue including a four-week post implementation monitoring period, in an amount not to exceed \$24,209.77.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The Work Order, a copy which is attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, for Doral Congestion Management Plan – Phase III, in an amount not to exceed \$24,209.77, , is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the work order and any necessary documents and to expend budgeted funds on the behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
