

RESOLUTION No. 13-75

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A FARMERS MARKET PERMIT FOR DORAL'S FARMERS' MARKET AND TO BE HELD AT 9525 NW 41ST STREET, DORAL, FLORIDA ON SUNDAY'S FROM OCTOBER 6TH, 2013 TO FEBRUARY 9TH, 2014 BETWEEN THE HOURS OF 9:00 A.M. TO 2:00 P.M.; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS; Human Powered ("Applicants") seek approval from the City of Doral for the Farmers' Market at Doral Center; and

WHEREAS, Staff respectfully recommends that Council approve the proposed Farmers' Market for to be held at Doral Center located at 9525 NW 41ST Street Doral, Florida, on Sunday's from October 6th, 2013 to February 9th, 2014 from 9:00 am to 2:00 pm, subject to the following conditions:

1. Construction plans for tents (larger than 10 X 10) and any structural facility must be submitted to the Building Department for approval.
2. Applicant shall obtain electrical permit for generators if required by the Building Department.
3. All City and State Licenses must be obtained prior to the opening of the Market.
4. All trash and refuse must be removed from the site at the end of each day.
5. Lighting must be provided during morning set up prior to sunrise if applicable.
6. Applicant shall furnish liability insurance of \$1,000,000 with the City as the certificate holder.
7. Applicant shall be required to enter into an agreement with the City of Doral Police Department for onsite security and traffic control for the first Farmer's Market Event. The action plan may be modified by the Police Department based on realized attendance of the event.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby approves the farmers' market permit for Human Powered to be held at Doral Center located at 9525 NW 41st Street Doral, Florida, on Sunday's from October 6th, 2013 to February 9th, 2014 from 9:00 am to 2:00 pm , subject to the conditions listed in the above "whereas" clause.

Section 2. WHEREAS, a motion to approve the Resolution was offered by, Councilwoman Fraga who moved its adoption. The motion was seconded by Vice Mayor Rodriguez Aguilera and upon being put to a vote, the vote was as follows:
