

**RESOLUTION No. 19-215**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO WORK WITH THE GREATER MIAMI CHAMBER OF COMMERCE TO HOST AN EVENT ON SEPTEMBER 26, 2019 AT THE DORAL GOVERNMENT CENTER INTENDED TO STRENGTHEN BUSINESS TIES IN OUR COMMUNITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, The Greater Miami Chamber of Commerce is a catalyst to help members grow, improve and protect their businesses. It is dedicated to building the best environment for business in the Americas and committed to improving the economic vitality of South Florida by educating and advocating for solutions to members' business needs; and

**WHEREAS**, The Chamber Connection is a monthly networking reception for professions (members and non-members) to to improve the community and to form a strong economic environment. They previously hosted an event at the Doral Government Center on May 24, 2018 as approved by Mayor and City Council; and

**WHEREAS**, the Doral Government Center would be the ideal location for business professionals from Florida Power & light, TD bank, UMiami Health, Carnival Corporations, Florida International University and other prominent names to meet and build connections; and

**WHEREAS**, the Greater Miami Chamber of Commerce, and the City of Doral desire to collaborate to host event on September 26, 2019 and providing support for the effort.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Authorization.** The City Manager is hereby authorized to work with the Greater Miami Chamber of Commerce to coordinate the use of facility for the September Chamber Connection event and allow use of City logo for promotion.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
