

RESOLUTION No. 21-174

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$45,000.00 FROM ACCOUNT No. 001.60005.500342 TO ACCOUNT No. 001.60005.500640; APPROVING THE PURCHASE AND/OR REPLACEMENTS OF AEDs, HANDHELD RADIOS, FIREARMS AND ACCESSORIES; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks approval for a budget transfer for the purchase and/or replacements of equipment used on the day-to-day operation; and

WHEREAS, Staff respectfully requests that the City Manager and City Council authorize the budget transfer from Cont. School Crossing Guard (#001.60005.500342) in the amount of \$45,000.00 to Capital Outlay Office (#001.60005.500640) for the purchase and/or replacement of equipment used daily.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The budget transfer from Cont. School Crossing Guard (#001.60005.500342) in the amount of \$45,000.00 to Capital Outlay Office (#001.60005.500640) for the purchase and/or replacement of equipment used daily.

Section 3. Authorization. The City Manager is hereby authorized to transfer the funds and expend budgeted funds on the behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
