

RESOLUTION No. 18-151

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR RACETIME, LLC. TO HOST THE “DORAL CORPORATE RUN 2018” AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166, TO TAKE PLACE ON THURSDAY DECEMBER 6, 2018 FROM 6:00PM-11:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the RaceTime, LLC. (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

WHEREAS, staff recommends the Mayor and City Council approve the proposed Outdoor Event Permit to host the “Doral Corporate Run 2018” event on Thursday, December 6, 2018 at Downtown Doral Park, located at 8395 NW 53 Street, Doral, FL 33166, from 6pm-11pm.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The outdoor event permit for the “Doral Corporate Run 2018” is hereby approved, subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Police Department prior to the event start date;
2. All building permits and inspections required by the Building Department shall be completed prior to the event start date;
3. Applicant shall provide a current certificate of insurance prior to the event start date;
4. Applicant is responsible to pay all outstanding city fees prior to the issuance of the Outdoor Events Permit;

5. Applicant shall provide courtesy notice of the event to all businesses affected by the road closures at least five days prior to the event. Such notice shall be provided to the Planning and Zoning Department at least three days prior to transmitting the courtesy notices to the businesses affected by the road closures; and
6. Applicant shall have an approved Maintenance of Traffic (MOT) from the City of Doral and any other local agencies in-place at least five days prior to the event.

Section 3. **Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. **Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
