SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from BCC Engineering, LLC dated November 24, 2021, for the Preliminary Section 7 Traffic Calming Assessment. The schedule requires the scoped of work to be completed within 60 days of issuing NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and materials basis not to exceed the amount of \$13,139.84.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 4, 2021 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

At the request of the City of Doral Public Works Department (City), BCC Engineering, LLC. (the Consultant) has prepared this scope of work to perform a qualitative assessment of traffic calming needs within certain areas of the northwest region of the City of Doral known as Section 7 in the City of Doral, Florida.

SCOPE BACKGROUND

The City of Doral commissioned a traffic calming study in 2015 for Section 7 located in the northwest quadrant of the City bounded on the west by Florida's Turnpike, on the east by NW 107 Avenue, on the south by NW 74 Street and on the north by NW 90 Street. Several traffic calming improvements established in that study have been designed and are subsequently being programmed for construction. However, at the time of the previous study and due to the lack of complaints, certain communities were excluded from the traffic calming review. These include the Menorca, Mediterranean, and Corsica residential communities.

Recently, the City received complaints from these three residential communities related to speeding and pedestrian needs requesting that the City further investigate and implement solutions to address the following:

Menorca

- Speeding on NW 115 Court between NW 82 Street and NW 84 Terrace
- NW 86 St both direction No stop signs nor speed signs
- Curve at NW 115th Av & 86 St No curve speed signs

Mediterranean

- Speeding on NW 109 Avenue
- Need for all-way stop or pedestrian refuge on NW 109 Avenue between the clubhouse and park

Corsica

NW 112 Ave between NW 74 St and NW 78 St - No stop signs nor speed signs

Prior to embarking upon an in-depth traffic calming study, the City desires to investigate these community concerns to help establish the need for further review and/or improvements. The Consultant has developed a scope of services, fee and schedule to perform the following.

SCOPE OF SERVICES

Task 1: Data Gathering/Review

The Consultant team will gather traffic data as summarized in Table 1 below and detailed in Exhibit A.

In addition to the data to be compiled as summarized in Table 1, the Consultant will conduct a field review to confirm field conditions and document any observations related to speeding or roadway user conflicts in any of the review areas.

The Consultant will compile all the data collected in this Task for use and analysis in the subsequent task.

Task 2: Qualitative Review & Technical Memorandum

Utilizing the data gathered in Task 1, the Consultant will conduct a qualitative assessment to confirm if the issues raised by the subject communities require further study or if minor remedial actions are available to address these issues. The Consultant will conduct the qualitative assessment according to guidelines/standards promulgated in various resources including but not limited to the latest versions of the <u>Manual on Uniform Traffic Control Devices (MUTCD)</u> published by FHWA, the Florida Department of <u>Transportation Traffic Engineering Manual</u>, the FDOT <u>Speed Zone Manual</u>, <u>FDOT Context Classification Guide</u>, <u>Miami-Dade Complete Streets Guidelines</u> and the <u>Miami-Dade Traffic Calming</u> Guidelines.

The Consultant will prepare a technical memorandum documenting findings and recommendations. One draft of the report will be prepared initially. The Consultant will prepare up to one revision of the draft as part of the preparation of a final report for agency submittal.

Task 3: Project Coordination & Meetings

As part of this task, the Consultant will attend an initial project kickoff meeting with City staff to confirm goals and objectives for the project, and obtain specific directions from the City to be followed during the performance of the services listed here in. Additional meetings and presentations will be conducted during this contract to coordinate efforts and inform stakeholders.

1. Meeting with other City Staff as directed by the City PM to present the findings and recommendations,

SCHEDULE

The estimated time to complete the draft submittal in Task 2 is 60 days from notice to proceed (NTP) or from receipt of "item(s) to be provided by the City" (whichever occurs last). An additional 45 days will be required to allow for agency review and for BCC to incorporate feedback received from such review.

ITEMS TO BE PROVIDED BY THE COUNTY

Upon execution of this agreement and prior to the receipt of notice to proceed, the County will provide to BCC information on:

- 1. Any available traffic data previously collected,
- 2. Major committed development activity for a qualitative review of potential future traffic impacts,
- 3. Programmed road improvements that could have an impact on traffic circulation within the review area.
- 4. Any planned changes to routes or schedules of transit / trolley service affecting the review area.

FEE AND BILLING

BCC will perform all services described in Tasks 1 through 3 of the Scope of Services for a time and materials basis with a not to exceed amount of \$13,139.84 without prior approval from the City. Following is a summary of estimated breakdown of the associated fee for each task described in this scope of services:


Exhibit 'A': Section 7 Traffic Calming Request Qualitative Assessment & Data Collection Plan





A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO PROFESSIONAL SERVICES AGREEMENTS WITH 300 ENGINEERING GROUP, A&P CONSULTING TRANSPORTATION ENGINEERS CORP., BCC ENGINEERING, EAC CONSULTING, GANNETT FLEMING, HW LOCHNER, KIMLEY-HORN, MARLIN ENGINEERING, STANTEC, AND THE CORRADINO GROUP; FOR THE PROVISION OF PROFESSIONAL ENGINEERING AND ARCHITECTURAL SERVICES; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to RFQ #2020-22 titled "Professional General Engineering and Architectural Services", the City of Doral received twenty-five (25) submittals by the August 7, 2020, 10:00 a.m. deadline; and

WHEREAS, the selected firms will be used to create a "pool" of pre-qualified consultants to provide professional general engineering and architectural services thereby reducing the costly and time-consuming process of individual solicitations; and

WHEREAS, this expedited process would follow the City of Doral Procurement Ordinance #2004-03 whereby any work in excess of the stated minimum is brought before the City Council for approval; and

WHEREAS, funding for the tasks assigned under these contracts will be budgeted each fiscal year; and

WHEREAS, Staff respectfully recommends that the City Council authorize the City Manager to negotiate and enter into professional service agreements with the following ten (10) firms: 300 Engineering Group, A&P Consulting Transportation Engineers, BCC Engineering, EAC Consulting, Gannett Fleming, H W Lochner, Kimley-Horn, Marlin

Engineering, Stantec, and The Corradino Group for the provision of professional engineering and architectural services;

WHEREAS, in the event the City cannot successfully negotiate with one of/or any of the firms recommended, staff and the City Manager are authorized to move onto the next highest ranked firm and commence negotiations, and so forth, until ten (10) firms have executed contracts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval of Rankings.</u> The City Council hereby approves the rankings of the ten (10) firms, attached as Exhibit "A", as provided by the proposals submitted.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to expend budgeted funds for professional services associated with this Professional Services Agreement.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall take effect immediately upon adoption.
