

RESOLUTION No. 18-06

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE HOSTING OF THE JR. DOLPHINS FOOTBALL SUMMER CAMP AT DORAL LEGACY PARK AND THE WAIVING OF FIELD RENTAL FEES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the “City”) is an active member of the Miami Xtreme Youth Football League, through which the Doral Broncos Tackle Football Program is offered; and

WHEREAS, in partnership with the Miami Xtreme Youth Football League, the City was approached by the Miami Dolphins to be the host site for their Jr. Dolphins Football Summer Camp (the “Camp”); and

WHEREAS, the Camp will be held at Doral Legacy Park on July 23-26, 2018 and have a maximum capacity of 200 participants; and

WHEREAS, the Miami Dolphins have agreed to provide 15 free camp registrations, which will be awarded to Doral Bronco Football participants, and 50 reserved spaces in the camp specifically for Doral residents; and

WHEREAS, staff finds that hosting this camp would be beneficial to the continued growth of the City’s Doral Broncos Tackle Football Program and recommended the City Council approve the hosting of the camp and waiver of the associated field rental fees.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. **Approval.** The City's hosting of the Jr. Dolphins Football Summer Camp, July 23-26, 2018, at Doral Legacy Park and the waiver of the associated field rental fees for the camp is hereby approved.

Section 3. **Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 4. **Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
