A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE FINAL PLAT FOR MIDTOWN AT DORAL, GENERALLY LOCATED ON THE EASTSIDE OF NORTHWEST 107 AVENUE AND NORTH OF NW 78 STREET, CITY OF DORAL, FLORIDA; PROVIDING FOR RECORDATION; PROVIDING AN EFFECTIVE DATE

WHEREAS, Ford, Armenteros & Fernandez, INC. ("the Applicant") is requesting final plat approval for Midtown at Doral Community Mixed Use (CMU), as depicted in Exhibit "A", generally located on the eastside of NW 107 Avenue and north of NW 78 Street, City of Doral, Florida, as legally described in Exhibit "B"; and

WHEREAS, this application has been reviewed for compliance with the City of Doral Code and Chapter 28 of the Miami-Dade County Code by the City Professional Surveyor and Mapper and has been found to be consistent; and

<u>Section 1.</u> Recitals. The above recitals are true and correct and incorporated herein by this reference.

<u>Section 2. Approval.</u> The City Council of the City of Doral hereby approves the final plat for Midtown at Doral Community Mixed Use (CMU), generally located on

the eastside of NW 107 Avenue and north of NW 78 Street, City of Doral, Florida, subject to the following conditions:

- 1. All PRM's have to be in place prior to the final plat recordation.
- 2. All PCP's and Lot corners have to be in place or bonded prior to the final plat recordation.

<u>Section 3.</u> Recordation. This Resolution shall be recorded in the Public Records of Miami-Dade County, Florida, with the Applicant to pay the costs thereof.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.


