

RESOLUTION No. 23-192

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE A MODULAR BATTERY 40KW UPS FROM CDW GOVERNMENT, LLC, IN AN AMOUNT NOT TO EXCEED \$52,698.09, UTILIZING TIPS CONTRACT No. 230105; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral's ("City") existing 40KW UPS (uninterrupted power system) environment, modular battery replacement, and modular power revitalization are in need of replacement; and

WHEREAS, modular battery replacement service is typically recommended every 3-5 years, and modular power revitalization service is typically recommended any time after 8 years; and

WHEREAS, the City's modular battery services is the original system that was installed at the time City Hall was constructed; and

WHEREAS, the system's reliability has gradually diminished, and the risk of power interruptions to the City's IT equipment has increased, therefore, to maintain the integrity of the City's data, protect against data loss, and minimize downtime, it is imperative that the City replace and revitalize the aforementioned system; and

WHEREAS, CDW Government, LLC can furnish and install the modular battery replacement, modular UPS revitalization, and associated services the City needs, and has provided the City with a proposal for the purchase of same; and

WHEREAS, CDW Government, LLC's proposal to the City is pursuant to their contract with the TIPS cooperative agency (Contract No. 230105), and pursuant to Section 2-322 of the City's Code of Ordinances, whereby the City is authorized to

purchase supplies, materials, equipment and contractual services which are the subject of contracts through cooperative purchasing ventures, when the best interest of the City would be served thereby; and

WHEREAS, City Staff respectfully requests that the Mayor and City Councilmembers authorize the City Manager to purchase 40KW UPS (uninterrupted power system) replacement modular from CDW Government, LLC, utilizing TIPS Contract No. 230105, in an amount not to exceed \$52,698.09, which funds are allocated in the IT Maintenance and Repair Account #: 001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval and Authorization. The purchase of 40KW UPS (uninterrupted power system) replacement modular and associated components from CDW Government, LLC, utilizing TIPS Contract No. 230105, in an amount not to exceed \$52,698.09, is hereby approved. The City Manager is further authorized to expend budgeted funds as provided for herein.

Section 3. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Puig-Corve who moved its adoption. The motion was seconded by Councilmember Porras and upon being put to a vote, the vote was as follows:
