

RESOLUTION No. 21-94

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE ISSUANCE OF A WORK ORDER TO WAYPOINT CONTRACTING, INC. FOR THE PROVISION OF CONSTRUCTION SERVICES AT THE DORAL POLICE TRAINING AND COMMUNITY CENTER IN AN AMOUNT NOT TO EXCEED \$37,545.00; AUTHORIZING THE CITY MANAGER TO APPROVE THE WORK ORDER AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as the City continues to grow, there is a need for the City's facilities to adapt and transform in order to address the needs of a growing staff and ensure that the best possible service is provided to the community; and

WHEREAS, on January 22, 2020, the Police Department requested from the Public Works Department (PWD) Facilities Maintenance Division a potential cost to design and develop a Simulation Room at the Doral Police Training and Community Center; and

WHEREAS, on June 17, 2020, the PWD provided a complete estimate to the Police Department for approval of the work; and

WHEREAS, on September 9, 2020, the Mayor and the City Council-Members adopted Resolution 20-175 (approved 5-0) approving the City Manager to issue a Work Order for A&P Consulting Transportation Engineers Corp. (APCTE) for the provision of Architectural and Engineering Services to design and develop a set of construction documents; and

WHEREAS, with the scope of work identified and a more accurate design in place, KI provided an updated estimate on December 16, 2020, for fabrication, delivery and installation of a Modular Architectural Walls System; and

WHEREAS, on January 13, 2021, the Mayor and the City Council-Members adopted Resolution 21-27 (approved 5-0) approving the purchase and installation of the architectural modular walls from Krueger International through the adopted Florida State Contract Florida State – Department of Management Services, Contract No. 56120000-19-ACS; and

WHEREAS, with the Construction Drawings approved, on March 18, 2021, the PWD requested TGSV to provide a proposal based on the set of Construction Documents prepared by APCTE; and

WHEREAS, TGSV's proposal exceeded budgeted funds; and

WHEREAS, the PWD requested a proposal from Waypoint Contracting, Inc. (Waypoint), and Waypoint provided a proposal in a not to exceed amount of \$37,545.00; and

WHEREAS, TGSV and Waypoint are part of the three (3) pre-approved General Contractors firms selected through the publicly advertised Request for Qualification (RFQ 2019-37); and

WHEREAS, funding for this request is available in the current Fiscal Year from the Police Department Fund, "Construction in Progress" Account, Account No. 001.60005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Work Order between the City of Doral and Waypoint Contracting, Inc. for the provision of construction of the Simulation Room at the Doral Police Training and Community Center in an amount of \$37,545.00, is hereby approved.

Section 3. Authorization. The Mayor and the City Council-Members authorize the issuance of Work Order 4 to and Waypoint Contracting, Inc. and to expend budgeted funds on behalf of the City in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
