**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF
THE CITY OF DORAL, FLORIDA MODIFYING COUNTY
RESOLUTION 5-ZAB-135-97 AS IT APPLIES TO THE
RELOCATION OF A PREVIOUSLY APPROVED
MAUSOLEUM AND TO RECONFIGURE PREVIOUSLY
APPROVED MAUSOLEUM; PROVIDING FOR AN
EFFECTIVE DATE**

WHEREAS, Applicant, Our Lady of Mercy, has requested a modification of Resolution 5-ZAB-135-97 which was adopted by the Miami-Dade Board of County Commissioners on April 16, 1997; and

WHEREAS, the requested modification applies to the relocation and reconfiguration of previously approved mausoleum; and

WHEREAS, staff has recommended that a modification of Resolution 5-ZAB-137-97 be approved; and

WHEREAS, upon due and proper consideration having been given to the matter, the City of Doral approves the modification of Resolution 5-ZAB-135-97 to relocate and reconfigure mausoleums, with the stipulation that all conditions of Resolutions 4-ZAB-154-89 and 5-ZAB-135-97 remain in full force and effect, except as modified as follows:

1. That the Applicant submit to the Planning Division for its review and approval, a landscaping plan which indicates the type and size of plant material prior to the issuance of a building permit and that all plantings be installed prior to the issuance of any Certificate of Occupancy;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

Section 1. The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.

Section 2. The modification of Resolution 5-ZAB-135-97 approved by the Miami-Dade County Commission on April 16, 1997 to relocate and reconfigure existing mausoleums, is hereby

1 approved with the stipulation that all conditions of Resolutions 4-ZAB-154-89 and 5-ZAB-135-97
2 remain in full force and effect, except as modified as follows:

4 1. That the Applicant submit to the Planning Division for its review and approval, a
5 landscaping plan which indicates the type and size of plant material prior to the issuance of a
6 building permit and that all plantings be installed prior to the issuance of any Certificate of
7 Occupancy.

8 **Section 3.** This Resolution shall be recorded in the Public Records of Dade County,
9 Florida, with the Applicant to pay the costs thereof.

10 **Section 4.** This resolution shall become effective upon its passage and adoption by
11 the City Council.

12 A motion to approve the application was offered by Vice Mayor Cabrera, who moved its
13 adoption. The motion was seconded by Councilwoman Ruiz and upon being put to a vote, the
