RESOLUTION No. 22-206

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE DONATION OF THIRTEEN (13) KRONOS CLOCKS IN "AS IS" CONDITION TO THE VILLAGE OF PINECREST, AS THEY UTILIZE THE KRONOS INCORPORATED HARDWARE AND SOFTWARE FOR EMPLOYEE TIME AND ATTENDANCE SYSTEM SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on October 13, 2021, Mayor and Council approved to award Paycom Payroll, LLC, to provide HRIS and Payroll Software for the Human Resources Department and Finance Department. Subsequently, implementation of the system was underway, and the city purchased Paycom Biometric Clocks that replaced existing Kronos Clocks located at facilities citywide. Effective April 25, 2022, the City went live with Paycom. As such, we experienced a seamless transition and removed all Kronos; and

WHEREAS, the City surplus stock assets (i. e. items that have outlived their useful life; or are no longer needed by any City department; or are no long cost effective to maintain; or that have become obsolete) are sold via public auctions for minimal value in an "as is' condition. In the past, the surplus computer equipment has been sold at auction in large volumes that include over 100 technology hardware items with nominal dollars obtained from bidders; and

WHEREAS, all documentation for surplus equipment that have been slated for disposal or donation is submitted to Procurement at the time it is placed in storage; and

WHEREAS, the City Manager's Office respectfully requests the Mayor and City Council authorize the donation of thirteen (13) Kronos Clocks in "as is" condition to the Village of Pinecrest as they utilize the Kronos Incorporate hardware and software for employee time and attendance system services. the condition of the Kronos Clocks, no warranties, expressed or implied, and assumes no responsibility.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The Information Technology Department recommends that the Mayor and City Council approve the donation of thirteen (13) Kronos Clocks in "as is" condition to the Village of Pinecrest as they utilize the Kronos Incorporate hardware and software for employee time and attendance system services.

<u>Section 3.</u> <u>Authorization.</u> The Mayor and City Council authorizes the donation of thirteen (13) Kronos Clocks in "as is" condition to the Village of Pinecrest as they utilize the Kronos Incorporate hardware and software for employee time and attendance system services. The City makes no representation as to the condition of the Kronos Clocks, no warranties, expressed or implied, and assumes no responsibility.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
