

RESOLUTION No. 06 - 22

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE DORAL LITTLE LEAGUE TO SUBMIT A BID TO HOST THE DISTRICT 8 LITTLE LEAGUE BASEBALL TOURNAMENT ON JUNE 26, 2006 THROUGH JULY 10, 2006 AT DORAL MEADOW PARK; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 16, 2006 the Doral Little League resolved to begin the process of bringing the District 8 Little League tournament to the City of Doral from June 26th, 2006 through July 10th, 2006; and

WHEREAS, before a formal bid to the District Administrator is made, it is necessary for the Doral Little League to secure the support and commitment of the City of Doral Parks and Recreation Department and would require the following from the City:

1. Doral Meadow Park to stay open until 11:00 p.m. throughout the duration of the tournament;
2. Outfield fencing and regulation size pitchers mounds on both fields;
3. All possible support to ensure that games are scheduled despite possible inclement weather in order to meet the strict time period allotted by the tournament; and

WHEREAS, the City of Doral Parks and Recreation Department has reviewed the request by the Doral Little League and is in favor of the initiative that would provide the City of Doral and its youth baseball program many benefits.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby approves the request from the Doral Little League to submit a bid to host the District 8 Little League Tournament at Doral Meadow Park and commits the support of the city's Parks and Recreation Department as specified above.

Section 2. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilman Van Name who moved its adoption. The motion was seconded by Councilwoman Ruiz upon being put to a vote, the vote was as follows:
