A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES ON THE NW 109 AVENUE ROADWAY IMPROVEMENTS PROJECT BETWEEN NW 41 STREET AND NW 50 STREET IN AN AMOUNT NOT TO EXCEED \$62,105.25; RECOGNIZING THAT A&P CONSULTING TRANSPORTATION ENGINEERS IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral wishes to secure a firm to provide Construction Engineering Inspection services ("CEI Services") for the construction of the NW 109 Avenue (NW 41 Street to NW 50 Street) Roadway Improvement project (the "Project"); and

WHEREAS, A&P Consulting Transportation Engineers is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2014; and

WHEREAS, Staff has recommended that the City Council approve the Work Order with A&P Consulting Transportation Engineers, a copy of which is attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, for the provision of CEI Services for the construction of the Project in an amount not to exceed \$62,105.25.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order No. 2 for CEI services on the construction of the NW 109 Avenue (NW 41 Street to NW 50 Street) roadway improvements in an amount not to exceed \$62,105.25, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

The City of Doral authorizes the firm of A&P Consulting Transportation Engineers to provide professional construction engineering and inspection services for the construction of NW 109 Avenue roadway improvements from NW 41 Street to NW 50 Street. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 20, 2015, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from A&P Consultant Transportation Engineers dated January 25, 2016 for Construction Engineering Inspection services on the project. The schedule requires the work to be performed within 120 calendar days. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$62,105.25.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 20, 2015 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
