

**RESOLUTION No. 19-286**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE PURCHASE OF 160 MP SERIES RIOT SUITS IN AN AMOUNT NOT TO EXCEED \$78,349.40 FROM SRT SUPPLY, A SOLE SOURCE VENDOR; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department requests to purchase 160 MP Series Riot Suits; and

**WHEREAS**, the Police Department respectfully requests to purchase one hundred and sixty (160) MP Series Riot Suits from SRT Supply, a sole source vendor. The Police Department needs the gear in order to conduct annual Field Force Training for all members and without such equipment and training the Department's operational readiness is minimized if called upon to deal with violent protesters. This equipment will enhance public safety by minimizing potential injuries to both officers and protesters, while ensuring the Department's ability to handle these types of events; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with SRT Supply, a sole source vendor for the purchase of one hundred and sixty (160) MP Series Riot Suits in an amount equal to \$78,349.40, and further requests that the City Council authorize the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager is hereby authorized to purchase one hundred and sixty (160) MP Series Riot Suits from SRT Supply, a sole source vendor in an amount not to exceed \$78,349.40 is hereby approved. This purchase is funded from the Operating Supplies Account #001.60005.500520.

**Section 3. Authorization:** The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the riot suits under the sole source letter provided by SRT Supply to expend funds in furtherance thereof in amounts not to exceed \$78,349.40.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
