A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO WAIVE THE COMPETITIVE BID PROCESS AND SERVICE AGREEMENT ENTER INTO A WITH FLEETWAVE FOR THE USE OF THE FLEET MAINTENANCE SOFTWARE, UNDER THE SAME TERMS, PRICING, AND CONDITIONS AS THE CURRENT CONTRACT IN AN AMOUNT NOT **EXCEED** DEPARTMENTAL BUDGETED **FUNDS:** AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; **PROVIDING** IMPLEMENTATION: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD), pursuant to Section 2-321 of the City Code, seeks to enter into a service agreement for an essential tool of a properly established and efficient fleet maintenance operation in the form of a capable fleet maintenance software; and

WHEREAS, at the October 2018 Council Meeting, the Mayor and City Councilmembers approved a four (4) year contract agreement with Chevin with an optional of a 5th year renewal which is set to expire on June 1, 2022; and

WHEREAS, the NJPA Contract is currently known as Sourcewell, and the current Sourcewell contract will not extend the Chevin Fleetwave contract after June 2022; and

WHEREAS, PWD respectfully requests authorization for the City Manager to waive the competitive bid process pursuant to Section 2-321 of the City Code, and enter into a Service Contract Agreement with Chevin for a one (1) year period under the same terms, pricing, and conditions, in an amount not to exceed the departmental budgeted funds, while staff performs research to procure a different software with a local provider that provides local support and more functionality.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

<u>Section 2.</u> <u>Approval.</u> The one-year Service Contract Agreement between the City of Doral and Chevin under the same terms, pricing, and conditions in an amount not to exceed the departmental budgeted funds for this item is hereby approved.

<u>Section 3.</u> Authorization. The City Manager is authorized to execute the Contract Agreement with Chevin for a one-year period under the same terms, pricing and conditions, and expend budgeted funds for this item on behalf of the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
