

RESOLUTION NO. 11- 31

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH LINK CONSTRUCTION GROUP FOR THE PROVISION OF CONSTRUCTION FOR THE N.W. 50TH STREET DOG-FRIENDLY PARK IN AN AMOUNT NOT TO EXCEED \$3,723,077.00; FURTHER AUTHORIZING THE CITY MANAGER, IN THE EVENT THAT AN AGREEMENT WITH LINK CONSTRUCTION GROUP CANNOT BE SUCCESSFULLY NEGOTIATED, TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE NUMBER TWO RANKED BIDDER AND, IF NECESSARY, THE NUMBER THREE RANKED BIDDER FOR THE PURPOSES AND IN THE AMOUNT AS STATED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to ITB #2010-29 titled "Dog Park Development Project," the City of Doral received twelve (12) bids by the October 27, 2010, 11:00 a.m. deadline for the development of the N.W. 50th Street dog-friendly park; and

WHEREAS, upon careful review of the bids submitted, it was determined that the lowest bidder was Link Construction Group; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Link Construction Group for the provision of construction of the N.W. 50th Street dog-friendly park in an amount not to exceed \$3,723,077.00; and

WHEREAS, in the event that an agreement cannot be successfully negotiated with Link Construction Group, Staff further requests that the City Council authorize the City manager to negotiate and enter into an agreement with the number two ranked bidder and, if necessary, the number three ranked bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The foregoing recitals are hereby incorporated by reference.

Section 2. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Link Construction Group for the provision of construction of the N.W. 50th Street dog-friendly park in an amount not to exceed \$3,723,077.00

Section 3. Further authorizing the City manager to negotiate and enter into an agreement with the number two ranked bidder and, if necessary, the number three ranked bidder for the purposes and in the amount as stated herein.

Section 4. This Resolution shall become effective immediately upon adoption.

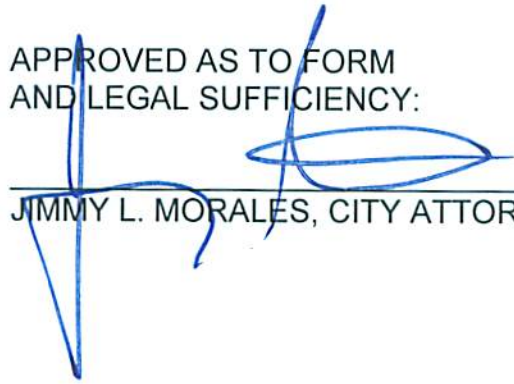
