The purpose of the overlay district is to facilitate the transition of the adaptive reuse study area north of Downtown Doral from an area dominated by a mix of heavy commercial and industrial uses to more vibrant community mixed-use center that fosters establishment of creative office, restaurant entertainment, and live work uses that remains an active economic center that provides opportunities for live, work, and play. At a minimum the overlay district will address purpose, authorized land uses, site development standards, building development standards and other applicable regulations. The work should be performed in accordance with attached Proposal dated June 10, 2019 submitted by your firm for the above referenced project.

#### SCOPE OF SERVICES AND SCHEDULE:

The scope of the project will be as described in the attached proposal from Tindale-Oliver & Associates, Inc. The schedule requires the work to be performed within 6 months from the notice to proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed based on a lump sum with a not to exceed amount of \$34,909.00.

You are required to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Professional Services Agreement approved on May 24, 2017 between the parties as though fully set forth herein. If any terms or conditions of this Work Order conflict with the Professional Services Agreement, the provisions of this specific Work Order shall prevail and apply.

Work Order is not binding until the City of Doral agrees and approves this Work Order.

# Doral Adaptive Reuse Study Area District Overlay Revised Scope of Services June 10, 2019

**Purpose:** To prepare an overlay district to facilitate the transition of the adaptive reuse study area north of Downtown Doral (see attached map) from an area dominated by a mix of heavy commercial and industrial uses to a more vibrant community mixed-use center that fosters establishment of creative office, restaurant, entertainment, and live/work uses that remains an active economic center that provides opportunities for live, work, and play.

**Work Program**: The following scope anticipates that the Consultant will work in collaboration with City Staff, drafting ordinances, preparing graphics and facilitating a stakeholder workshop that will result in the preparation of an overlay district that City Staff will guide through the public hearing and adoption process.

**Task 1: Outline Regulatory Changes.** Prepare an annotated outline of proposed regulatory changes that identifies applicable sections of the City's land development regulations for amendment and describes the substance of proposed changes to create and implement a new overlay zoning district. The outline will identify key regulatory decisions and options available to the City.

**Task 2: Review/Revise Outline**. Review the annotated outline with Staff and revise the outline as necessary to ensure that Consultant and City Staff concur on the substance and organization of procedures and standards to be incorporated in the proposed overlay district. This review will be an inperson meeting with staff at their offices. It is assumed that there will be one member of the Tindale Oliver Team in attendance.

**Task 3: Prepare Working Draft**. Prepare a working draft of the overlay district that will, at a minimum, include text, tables and graphics addressing the:

- Purpose of Overlay District
- Applicability
- Authorized Land Uses
- Arrangement of Land Uses
- Site Development Standards
- Building Development Standards
- Conditions Applicable to Specific Uses in the District

In addition to the draft code changes prepared as part of this task, draft strikethrough/underline changes will be prepared for the Comprehensive Plan. These changes will be focused on additional language that refines allowable uses and articulates the desired flexibility within the proposed overlay. This language is expected to be limited to the Future Land Use Element, and will be prepared for the working draft under this task and provided to staff for their review/use. It is assumed that staff will complete the formal amendment process.

Task 4: Review/Revise Working Draft. Review the draft in a teleconference with City Staff to identify potential changes and supplements required to adequately address the City's objectives for changing

uses and development within the overlay district. Following the teleconference, Consultant will prepare a public review draft ordinance and summary for review by stakeholders in task 5.

**Task 5: Facilitate Stakeholder Workshop**. Prepare for and facilitate a workshop with stakeholders to discuss proposed provisions and identify potential refinements that will better achieve the City's project objectives. As an option, Consultant can meet with elected and appointed officials to discuss the proposed overlay district provisions on the same day as the stakeholder workshop. City Staff will be responsible for securing meeting facilities and inviting stakeholders to the workshop.

**Task 6: Prepare Public Hearing Draft.** Based on task 5 input, revised the public review draft to prepare a public hearing draft for consideration during the adoption process. A Tindale Oliver Team member will attend one Planning Commission or City Council Public Hearing for a presentation and to answer any questions.

**Task 7: Revise Public Hearing Draft.** Following adoption by the City, incorporate any changes proposed during the hearing and adoption process and provide a clean, adopted copy of the overlay district.

**Milestone Schedule:** The overall project timeline is six months from Notice to Proceed (NTP). The milestone schedule below is dependent upon successful scheduling of public hearings as required.

WHEREAS, the City of Doral Planning and Zoning Department wishes to secure Tindale-Oliver & Associates, Inc. to provide professional planning services to prepare the "Doral Adaptive Reuse Study Area" District Overlay to provide authorized uses, site development standards, building development standards and other regulations applicable in the District; and

WHEREAS, the District Overlay will facilitate the transition of the study area north of Downtown Doral from an area dominated by a mix of heavy commercial and industrial uses to a more vibrant community mixed-use center that fosters establishment of creative office, restaurant, entertainment, and live/work uses that remains an active economic center that

provides opportunities for live, work, and play; and
