WHEREAS, the dedication of the right-of-way from the City of Doral for a portion of Tract 26 in Section 17 will be used to expand the City's roadway grid in the general area of N.W. 66th Street along N.W. 104th Avenue; and

WHEREAS, the City Council hereby finds that adoption of this resolution is in the best interest and welfare of the residents of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 2.</u> <u>Approval.</u> The City Council of the City of Doral hereby approves the dedication of the Right-of-Way from the City owned land for a portion of Tract 26 in Section 17 in the City of Doral as specified in Exhibit A.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
