

**RESOLUTION No. 24-234**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE RENEWAL OF CLEARVIEW AI SOFTWARE, A SINGLE SOURCE VENDOR, IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS FROM ACCOUNT No. 001.22005.500460; AUTHORIZING THE CITY MANAGER TO WAIVE THE COMPETITIVE BIDDING PROCESS, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE RENEWAL; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department seeks approval for the renewal of Clearview AI software, a sole source vendor.

**WHEREAS**, Clearview AI provides law enforcement agencies with greater insight and lead generation through the use of our investigative platform.; and

**WHEREAS**, Clearview AI is an investigative tool for the Criminal Investigations Section (CSI) and the Real Time Operations Center (RTOC). The Doral Police Department's CSI and RTOC, utilize the platform and can expect to receive high-quality leads with fewer resources expended. These leads, when supported by other evidence, can help accurately and rapidly identify suspects, persons of interest, and victims to help solve and prevent crimes.

**WHEREAS**, Pursuant to Section 2-321 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to waive the competitive bidding procedure with Clearview AI (a sole source vendor) for the renewal of the software for CSI and the RTOC in an amount not to exceed budgeted funds from IT-Repairs and Maintenance, Account No. 001.22005.500460.

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-321, waive the competitive bidding procedure for the renewal of Clearview AI (a single source vendor) software in an amount not to exceed budgeted funds from IT-Repairs and Maintenance, Account No. 001.22005.500460 or other most appropriate account(s) as approved in the budget is hereby approved. The Agreement has a period of three (3) years, commencing October, 2024 and ending September, 2027.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
